As a result, our network of Child Care Resource & Referral programs (CCR&Rs) completed 2014 on even more solid footing than the year before. The CCR&R network began 2015 better positioned to promote higher quality early learning services for the State's youngest residents, who represent New York's Foundation for Tomorrow.

2015 marks the 40th anniversary of the Early Care and Learning Council. Late in September we will be officially celebrating that event, but it's important that we take note of it now. Because of new opportunities before us, we cannot afford to be shy about what we have accomplished.

2015 is a year to celebrate 40 years of accomplishments – and the year we will be laying our own Foundation for

Tomorrow. Over the past 18 months the 35 CCR&R network that is ECLC has been preparing for this year, through the efforts of various member-driven work groups addressing areas for growth and development, including: Diversity & Inclusion; Branding & Marketing; Legally-Exempt Providers; Quality Improvement, and Visioning.

New York State welcomes 250,000 new babies each year.

This is a cause for celebration and also highlights the **great need for high quality child care options**. In New York, where there are more than 1,180,000 children under the age of five, most parents are working parents whose effectiveness in our workforce depends, in part, on their confidence that their children are receiving quality early learning services.

Forty-six percent of child care requests in New York are for infants and toddlers, whose child care expenses typically exceed that of a single parent's income (minimum wage), so it is *essential* that community groups work together to make healthy development for New York's kids a possibility while supporting our working families, local economies and skilled workforce.

To continually have resources needed to meet the needs of our communities in all of New York's 62 counties, the vast network of New York Child Care Resource and Referral agencies (CCR&Rs) continues to grow and expand in order to remain relevant to the population they serve.

How do we make this happen? As the membership hub for the CCR&Rs, ECLC works with all 35 agencies to strengthen the quality and accessibility of child care across New York State, as it has since 1975. It provides direct training and technical assistance to CCR&Rs so they can support 20,000+ child care providers in New York State to provide safe child care environments that will best prepare children for school and ensure healthy development.

Many of ECLC's 2014 activities illustrate this deep collaboration. For example, more than 390 hours were dedicated to maintaining the New York Standards of Excellence and Child Care Aware of America Quality Assurance Standards. We provided thirty-eight workshops for child care center directors, training more than 315 directors across the state.

More than 35 site visits from ECLC staff provided training in **data collection** for reporting, research and evaluation, needs assessments, theory of change planning for twenty-

four infant toddler specialists, and capacity building to generate adequate resources to maintain quality programming through fundraising, marketing, social media outreach and enhancing visibility throughout the state. The Infant Toddler Network provided more than 5,200 hours of training and 2,000 hours of technical assistance across the state.

ECLC provided ongoing professional development opportunities, including its 2-day leadership summit, *Educate*, *Engage*, *Empower*, as well as its annual meeting and luncheon, *Dream*, *Believe Achieve*, which honored early childhood champions Assemblyman Richard Hanna, Assemblyman Angelo Santabarbara, Heritage Christian Services, and Mark Eagan of the Albany-Colonie Regional Chamber of Commerce.

We saw progress. Advocacy initiatives in 2014 focused on securing more funding for quality child care programs. ECLC and CCR&Rs successfully obtained increased funding for additional child care subsidies statewide, and deepened policy partnerships with state and national organizations. ECLC served as a sponsor of the *What's Great in Our State* Children's Mental Health Awareness Day and participated on the Winning Beginning NY Steering Committee, as well as the NYS Breastfeeding Coalition Board of Directors.

Through generous foundation grants, ECLC facilitated the creation and kickoff of three, fully engaged **Business Leader Workgroups** in the Finger Lakes, Long Island and Mohawk Valley regions. They convene and educate corporate leaders to become champions for high quality, accessible child care, a benefit to their current and future skilled workforce, as well as the New York State economy.

Lending support to early learning and development initiatives in New York isn't just for those of us in the field. It is everyone's business, from the corporate CEO concerned with attracting and maintaining a skilled workforce, to teachers, colleges, law enforcement, and the military, to name just a few. Today's young children are the foundation of New York's future and *they need a strong start*.

Business leaders have become the "surprise messengers" advocating for quality child care. Economists tell us that the early years represent an important window of opportunity to provide young brains with developmentally appropriate education because it is the moment of greatest leverage.
